RESOLUTION

**On Improving Laws Regarding Automatic Weapons,
Semi-Automatic Weapons, and Large Capacity Magazines
without Infringing on Constitutional Rights to Bear Arms**

WHEREAS there are insufficient resources at all levels to deal with mental health issues;

WHEREAS we want to support police officers;

WHEREAS depending on a good person with a gun is not adequate protection;

WHEREAS arming teachers and school officials is not adequate;

WHEREAS fortifying our schools is not adequate.;

WHEREAS we also want to safeguard the right to life, liberty and the pursuit of happiness while supporting basic 2nd amendment rights to bear arms;

Therefore, be it **RESOLVED** that

The mayor and city council of Oxford, Georgia, support state and federal elected officials in writing and passing stricter laws regarding the purchase and license of automatic weapons, semi-automatic weapons and large capacity magazines;

Buyers and owners of automatic weapons, semi-automatic weapons, and large capacity magazines should be at least 25 years of age;

Buyers of automatic weapons, semi-automatic weapons, and large capacity magazines should be subject to a waiting period of three (3) months before taking possession of the weapon;

Buyers and owners of automatic weapons, semi-automatic weapons, and large capacity magazines should pass a safety course and be licensed to operate these weapons;

Buyers and owners of automatic weapons, semi-automatic weapons, and large capacity magazines should be required to renew licenses and background rechecks at least every five (5) years; and

Buyers and owners of automatic weapons, semi-automatic weapons and large capacity magazines should be required to have liability insurance.




