Mayor Roseberry announced that GDOT has informed us that the intersection at state route 81 and 142 will be completed by the end of this year. They have approved the final design. The major design change was for the south bound traffic making it easier to merge onto 142.

Civil War Heritage Trail Marker Signs Request

Councilmember Mike Ready gave a report on the Civil War Heritage Trail markers. He showed diagrams and recommendations on suggested areas of where to place three of the markers on the city streets, and indicating one additional sign would be placed on Emory Street/State Highway Route 81 which would be placed according to DOT's regulations. He presented an example of the signs and made a suggestion that the signs be at 12 feet high rather than the suggested 15 feet high and suggested the sign be on a green post rather than the silver post. Mayor Reports

Mayor Roseberry announced that on March 24, 2016 the City hosted a meeting of the Board of Commissioners and Mayors of Newton County. This was the first of future meetings.

Mayor Roseberry announced the City is experiencing a loss of the new city limit signs. He asked Jody Reid Utility Superintendent if they have come up with a way to connect the signs that would deter theft of the new signs. Reid said they are now connecting them with pad locks to see if that will help.

Mayor Roseberry announced that County Commissioner Henderson's son is in Grady Hospital in intensive care from an accident and he asked that everyone keep him in their prayers.

July 4th Committee

Councilmember Davis reported that after their meeting it was decided to nominate James Watterson as Grand Marshal for 2016.

A motion was made by Davis, seconded by Windham to appoint Jim Watterson as Grand Marshal for the 2016 July 4th Parade. The motion was approved 7/0.

George Street Trail Extension

City Manager Bob Schwartz presented pricing estimates and maps depicting the trail options prepared by City Engineer Robert Jordan for several alternatives for the George Street Trail Extension with a recommendation to move forward with Option 1. After discussion:

A motion was made by Windham, seconded by Eady to move forward with Option 1. Eady noted that Option 1 will still leave approximately 300 feet from the Wearing's property. The motion was approved 7/0.

Oxford College Utility Relocation Project

City Manager Bob Schwartz presented to council a request from Oxford College for the conversion of the overhead electric system to an underground system in the vicinity of Pierce, George Street, and Wesley near the new dining hall and the old dining hall. Schwartz presented the bids for the Oxford College Project with recommendations to accept the bids from Marable-Pirkle at \$490,070.00 for labor, Materials from Irby (w/o poles) at \$169,676.70, Sole Source Contracts from Stuart's Electrical Services Inc. at \$98,200.00, Charter Cable \$12,180.00 and AT&T for \$11,356.00. In addition Mayor Roseberry stated that based on ECG's billing dated 6/30/2015 the city is charged \$187.50 per hour from ECG services and estimating that 40 hours of ECG services will be required for the project the city will bill Emory \$7,700 for ECG services. City Manager Bob Schwartz presented a service contract for approval. After review of the contract, Eady suggested to include a description of the location of the project and scope of work. Windham questioned including a retainer of 10%. Smith stated there is no inclusion of the City of Oxfords employee based on the amount of work being done and time spent at the College for these projects. After discussion it was suggested that City Manager Schwartz meet with the City Attorney David Strickland to review the contract and make the suggested changes. Attachment G

A motion was made by Ready, seconded by Holt to proceed with the approval of the contract with the changes as discussed. The motion was approved 7/0.

Cemetery Agreement

City Manager Bob Schwartz presented the revised renewal agreement with the Oxford Historical Cemetery Foundation as was discussed at the past two work sessions. Eady said we should specify the caliber of trees. Schwartz will discuss with Burl Budd and include his recommendations. Attachment H

Mayor's Announcements

- 1. Re: Civil War Marker, Georgia Department of Transportation has approved the March to the Sea markers. Councilmember Mike Ready will make a presentation at the May 2nd meeting.
- 2. May 26th is a Water Summit Meeting at the Center @ 10:00 am to discuss the future of water systems in Newton County.
- 3. We will have to go through the Water First Recertification. This will be facilitated by Newton County Tomorrow; the city will be required to participate in certain aspects of this recertification.
- 4. The city will also participate in the Newton County Comprehensive Transportation Plan that will be handled by ACOM a company out of Atlanta with Newton County Tomorrow assisting with this project.
- 5. The Budget Work Session is scheduled for Monday, April 25th at 6:00 pm.
- 6. Budget Committee Mayor Roseberry appointed Councilmember George Holt to chair the committee with assistance from Councilmembers Terry Smith and Jim Windham. Mayor Roseberry also asked the budget committee to review city contract for Old Church.
- *UGA Project Report The meeting was turned over to Pratt Cassity, director of the
 University of Georgia Center for Community Design and Preservation. Cassity presented a
 Mid-Point Presentation of the Special Projects Study.
 Cassity said they titled this project "Oxford Design Choices". The project is to provide
 critical choices to proceed with community improvements and a plan to help make them easy.

First concept referenced Visual Preference Decisions – Oxford needs a visual decision making tool. This workshop will lead to a way to evaluate decisions and move forward on changes.

Cassity indicated because there are so many choices..... Sometimes the number of choices can make things more difficult. He outlined the project based on the following items.

Workshop Themes where they reviewed:

Clarity
Design Excellence
Access to Green space
Asset-based Problem Solving and
Quality of Life-

The Components of the Project include:
Asset Map/Iconic Infographic /GIS-Arwen Chin
Historic Resource Survey – Find It! Program
Ideas of Community baseline research and analysis- by Stephen Ramos

THE DESIGN WORKSHOP

A planning atelier in May for Asbury Park - Doug Pardue

They presented common themes of modern architecture which included:

"Form follows function", a dictum expressed by Frank Lloyd Wright's early mentor Louis Sullivan, meaning that the result of design should derive directly from its purpose.

Simplicity and clarity of forms and elimination of "unnecessary detail."

Materials at 90 degrees to each other.

Visual expression of structure (as opposed to the hiding of structural elements)

"Truth to materials", meaning that the true nature of a material ought to be seen rather than concealed.

Use of industrially-produced materials; adoption of the machine aesthetic.

He outlined Oxford's Historic Resources Based on Age stating that a large portion of properties in Oxford are 40 years old. He also showed the vacant or City owned properties, property younger than 40 years and property owned by Emory at Oxford.

He spoke in reference to Oxford's New Town Center -

An idea whose time has come or a concept in need of updating? He said that after discussion and thought -- Maybe an interim update is needed. He presented The Design Workshop's HYBRID PLAN explaining how to connect the dots with a map explaining the importance of Nodes and what they mean. -

Nodes are destinations or restful spots,

Paths connect nodes,

Nodes connect to make trails,

Trails encourage walkability

He discussed the importance of signs, their type, design and meaning. He talked about design hierarchy in relation to softer treatments and formal treatments. He discussed the need for sidewalks and how they play a part in safety through design and connectivity. He touched on the Rosenwald School slating it a Historic Site (ruins) and a proposal for the Corner Store at W. Soule and Emory slating it a possible trail head. He pointed out areas of concern where subtle transition is needed and areas where less intervention and more vegetation is needed

and protected. Mr. Cassity concluded in saying that still to come out of this study will be a GIS layer with all assets located and named, edited asset map suitable for a logo. They will provide a report on the design workshop with finalized images, funding recommendations and programming text. They will present a New Park Plan (Maymester) with at least 2 community events with the dates to be announced.

2. * FY2017 Annual Budget

City Manager, Bob Schwartz gave a short PowerPoint presentation depicting the various funds for each department showing the year end budget for FY2015 with an estimate through March of FY2016 and a recommended FY2017 with a percent of change.

There was discussion regarding LMIG money set aside by GDOT for safety. Newton County Cities may receive as much as \$200,000 to be used for off system projects (not on state highway) such as stop bars, guard rails, pedestrian crossings, raised brick cross walks at entrance to trails, speed rails, stripping etc. The deadline for submission is Friday, April 29, 2016.

Mayor Roseberry explained that the Local Option Sales & Use Tax is computed on several factors. Oxford's share is figured at approximately 3.02% but in the future it could be less depending on a number of factors.

There was discussion regarding the contract with the Oxford Historical Society and repairs to Old Church. Councilmember Sarah Davis said that the Oxford Historical Society has paid for all repairs and maintenance since taking over responsibility for the management of Old Church.

City Manager, Bob Schwartz concluded the meeting with the following list of items remaining to be discussed by the Budget Committee.

Review utility rate structures.

Make recommendation on employee raises.

Review the LOST receipts prediction.

Final recommendations on Capital Projects.

Review detailed appendix for some expenditure accounts.
