Minutes of Meeting January 19, 2021

Community Room, Oxford City Hall (Via Video Conference)

Call to Order: At 5:02 PM, Chairman Ready called the meeting to order and welcomed the guests.

Agenda for Meeting: Upon motion of Mr. Rogers, seconded by Ms. Eady, the agenda for the January 19, 2021 meeting was adopted. The vote was 6-0.

Minutes of Meeting held December 8, 2020: Upon motion of Ms. Eady, seconded by Mr. Rogers, the minutes for the meetings held December 8, 2020 were adopted. The vote was 6-0.

Status of Work Plan, FY2021, Beryl Budd: The Board agreed to discuss FY2021's tree pruning project later in the meeting.

Approval of FY2021 Budget: The Board reviewed the document listing their proposed FY2021 budget. The categories included the following: 2021 Arbor Day, Tree Planting, Pruning (Crown & Structural), Educational Costs, Donations, and Arborist Fees. The Board discussed possibly adding a category for recreation-related activities. The Board discussed beginning work on their budget request for FY2022.

Upon motion of Ms. Eady, seconded by Mr. Rogers, the Board approved the proposed allocations for the FY2021. The vote was 6-0.

Mission Statement and Vision Statement: The Board reviewed the final draft of the document containing their mission and vision statement. The Board agreed to send it to the Mayor and City Council for their review.

Maintenance Concerns:

- 1. Bench at Mitchell Street Park: Ms. Ready shared that she met with Mr. Pepper and Mr. Reid at the park to identify a couple locations to install a park bench. Before installing the bench, Ms. Ready will contact Mr. Wright for feedback on the proposed locations.
- 2. George Street Park (Split-rail fencing bids): Mr. Pepper reported to the Board that staff has had difficulties finding a fence contractor that meets the city's insurance requirements and is

interested in completing a relatively small fence project. He will continue to look for a fence contractor.

- 3. Asbury Street Park Replacing Ginkgo Trees: The Board discussed with Mr. Budd possible replacements for the existing Ginkgo trees at the park. Two of the options discussed were hornbeams and black gums. Mr. Pepper shared that Mayor Eady requested that the recommended trees have a large enough canopy to provide shade for visitors, especially for those using the playground. Mr. Budd will provide the Board with his recommendations, which Mr. Pepper will then share with the Mayor and City Council.
- 4. Tree City/Growth Award The Board discussed documenting different projects undertaken by the Board to include in the Growth Award application.

Pruning Issues – Tree Selection: Mr. Budd received three (3) proposals for this year's pruning project. The bids were as follows: Caldwell Tree Care (\$9,388); Rayfield Tree Care, Inc. (\$4,450); and Arbor Equity \$4,320. The Board reviewed the bids. Mr. Budd recommended that the Board award the contract to Arbor Equity.

Upon motion of Ms. Eady, seconded by Mr. McQuaide, the Board awarded the contract for FY2021's tree pruning project to Arbor Equity for \$4,320. The vote was 6-0.

Arbor Day, 2021: The Board discussed the city's upcoming Arbor Day event. Ms. Eady expressed her concern with hosting a city-sponsored event during the pandemic. As positive cases have continued to rise in Georgia, the Board agreed that it would be difficult to safely host Arbor Day at Asbury Street Park. Ms. Ready recommended that the Board request that Mayor Eady read the city's Arbor Day Proclamation at the February 1st City Council Meeting. In addition, the Board would present the Friends of Trees award to the city's maintenance crew at the meeting.

In addition, the Board discussed ideas on how to best plant about fifty (50) seedlings that Mr. Budd had received in anticipation of the event. They decided that many of the seedlings could be planted in the wooded area at Asbury Street Park, others potted, and the remaining given to Oxford College to be used in a joint-planting effort.

Upon motion of Ms. Eady, seconded by Mr. Rogers, the Board suspended the city's Arbor Day event for 2021 due to the safety concerns presented by the COVID-19 Pandemic. The vote was 6-0.

Naming Rights at Asbury Street Park: Mr. Pepper shared that a resident recently approached the city about having a bench at Asbury Street Park named in honor of their family. They are willing to make a donation to the city in exchange for the naming opportunity. Mr. Pepper explained that during the park's construction, the Oxford Lions Club donated a bench. In return, the city installed a plaque on the bench stating that it was donated by the Lions Club. In addition, the city installed a plaque honoring Ms. Helen Griffin's family as a condition of acquiring the property. Other than those two instances, the city has not named any other equipment or area after a specific person or family.

The Board discussed several naming option ideas including planting honorary trees, installing bricks, and a donation wall. They also discussed redirecting residents to the existing city trail. Mr. Pepper will research similar programs offered by other cities. The Board also discussed focusing on allowing individuals to name a bench while they work to develop a broader program.

Arbor Day Foundation Donation: Ms. Ready reported that the Board plans to make a donation to the Arbor Day Foundation.

Discussion on Filling Vacancy: The Board discussed the existing vacancy. Mr. McQuaide will contact Ms. Barbara Cole to discuss with her the possibility of joining the Board.

Concerns and Announcements: Mr. Hawkins reminded the Board about the Tree City USA Virtual Conference that will take place on February 10th, 17th, and 24th. Board members can attend the conference for free using a promotional code.

Adjournment: At 6:29 PM, Chairman Ready adjourned the meeting.

Next meeting will be at 5 PM on February 16, 2021.

Ideas for Guidelines for Park Donations:

This is a draft list of possible requirements we can adopt for individuals requesting an opportunity to donate money to Asbury Street Park in exchange for the naming rights to an item (bench, picnic table, etc.) in the park.

- 1. Pay for the entire item. For example, a park bench is nearly \$1,000.
- 2. What items are available for donation?
- 3. Resident of Oxford or Newton County.
- 4. Receive approval from the Tree Board and City Council.
- 5. Limit one item per family.
- 6. We will need to think about the process to replace a donated item.

Oxford Tree Pruning 2016 – 2021

Arborist Connie Head completed the Oxford Tree Inventory and updated it in 2010. Based on her recommendations there was a total of 258 trees in need of pruning at that time. Of these 113 were for crown cleaning and 95 were for structural/training pruning. I began work in 2014 as Oxford's Arborist so I am not sure how many trees may have been pruned after her inventory update in 2010 and prior to my start in 2014. I would suspect very few since the budget was only about \$5000 annually at that time. Since 2016 the Trees, Parks, and Recreation Board has devoted annual funding for tree pruning. About \$4,000 to \$5,000 has been spent annually for pruning and you can see the number of trees pruned below.

My estimate, based on the tree inventory, there are at least 250 large trees on City property and Right of Ways. Getting these trees on a 10 year pruning cycle would be about 25 trees each year. Some of the largest, oldest, and declining trees may need to be pruned more often.

My estimate on younger trees (up to 20 years old), that are in need of structural pruning every 5-10 years, is at least 300 trees. This pruning, which is often neglected, helps in developing tree form and structure and eliminates many problems the tree will develop as it gets larger. Structural pruning reduces cost later on by reducing tree failures and expensive pruning when the trees get much larger. My estimate is 20-30 trees annually for structural pruning.

To accomplish the goals mentioned above the pruning budget would need to be doubled to about \$8,000 to \$10,000 annually.

MISSION

Oxford's Trees Parks and Recreation Board strives to enhance and maintain the trees and vegetation on City owned property while providing spaces for enjoying healthy outdoor recreation, and outdoor gathering spaces for residents, and to conserve our natural, cultural, and historical resources.

VISION

Oxford will remain a community which values, respects, and preserves the natural environment, including our majestic trees within the City limits of Oxford for all to enjoy.

PURPOSE

- Maintain trees within the City limits in a healthy and nonhazardous condition through professionally accepted arboricultural practices in consultation with the City Arborist.
- Establish and revise as necessary standards for planting and maintaining trees in order to improve the economic base of the City by improving property values, to enhance the visual quality of the City and its neighborhoods, and to improve public health by reducing air pollution and the incidence of flooding.
- Establish and maintain the maximum amount of tree cover on public and private lands within the boundaries of the City.
- Advocate for a "no net loss" of trees policy within the boundaries of the City. Advocate for policies in the City that support the continued enjoyment of the benefits provided by the forests.
- Assist the City Arborist in establishing and maintaining a record of historic trees, specimen trees, and other environmentally significant trees within the boundaries of the City.
- Adhere to the Tree City Guidelines to continue to maintain the Tree City designation for Oxford.
- Encourage and support community involvement through the National Arbor Day celebration and other community events.
- Provide mentoring and encouragement for private property owners to maintain and enhance the native flora on their property.
- Provide and maintain trails and parks for limited recreational activities.
