#### TRANSFER OF FUNDS

The second design was a roundabout layout with an estimated cost of \$188,492. ZONING AMENDMENT — City Manager Bob Schwartz presented the request from Oxford College. Oxford College purchased four lots on the east side of Emory Street. They have asked to rezone three of these lots (602, 604 and 608 Emory) from R7.5 to IC (Institutional Campus). At this time they are not requesting any change in the zoning for the larger lot (approximately 12 acres) which, if it had a house on it, would be numbered 606. The Planning Commission reviewed this request on Tuesday, March 10. After considerable discussion, the Planning Commission recommended that the three lots be rezoned to IC-TA (Institutional Campus — Transitional Area) subject to the conditions and limitations that the only permitted use be residential uses consistent with the existing land use plan and office use (approved as a conditional use in the IC-TA zone) provided that the properties continue to appear as single family residential use.

If the zoning change is approved, then the Oxford College Future Development Plan will be amended to include these four lots as college property with the conditionally approved use as offices for the three houses. After review and discussion of this request.

A motion was made by Holt, seconded by Smith to accept the proposal from Planning Commission for the rezoning of the three lots (602, 604 and 608 Emory) as described. The vote was 4 in favor with 2 opposed Councilmembers Jim Windham and David Eady were opposed, Councilmember Lyn Pace was not in attendance. The motion was approved. Attachment L

#### PLANNING COMMISSION RECOMMENDATIONS/PETITIONS

Planning Commission Chairman Mike Ready gave an update regarding the Development request from property owner Gina Ruggeri located at 201 Williams Street for the addition of a 400 square foot garage to the east side of the property attached to the house. The Planning Commission had instructed Ms. Ruggeri that a survey would be needed to clearly determine the setbacks. Ms. Ruggeri provided a survey prepared by Jordan Engineering depicting the required setbacks with a 30 ft. build to line on the Williams Street side and a 10 ft. build to line on the Asbury Street side. Based on these findings the Chair of the Planning Commission approved the Development request.

#### **CITIZENS COMMENTS/CONCERNS**

Mr. Michael Besaw – Mr. Besaw presented a letter to Council for the purpose of the possibility of him purchasing a parcel of city property adjacent and behind his property at 1020 Emory Street. Mr. Besaw stated this parcel would allow him driving access to the front of his house to allow a handicap access to the front door so certain members of his family can enter with ease and without trouble. #### **Mayor's Reports**

Mayor Roseberry made the following announcements and Reminders:

- 1. ARBOR DAY IN OXFORD The Arbor Day celebration on Saturday February 21<sup>st</sup> was excellent by any measure. We owe special thanks to the Tree Board leaders and volunteers. This is Oxford's 17<sup>th</sup> year as a Tree City. It was a joint celebration with Oxford College which was awarded its first Tree Campus designation.
- 2. CITY AND COLLEGE MEETING The mayor and council will meet with Oxford College Dean Stephen Bowen, Myra Frady and other college representatives on March 5<sup>th</sup> at 10:00 am in the community room. The college will present an update on construction and newly acquired property. All council members are invited to participate in the meeting. The meeting is open to the public.
- 3. ECG & MEAG Solar Initiative If you registered for the ECG MEAG Solar Initiative meeting (deadline was 2/27/15), it is scheduled for March 9, 2015 at the MEAG Training Center, 148 Powerhouse Road, Forsyth, Georgia. There will be a presentation on the possible impact of recent state legislation on MEAG cities.
- 4. ENVIRONMENTAL PLANNING: Opportunities and Financing Available NEGRC will host an educational workshop on environmental planning at their offices in Athens from 10:00 am until noon on March 24<sup>th</sup>. Registration deadline is March 19<sup>th</sup>. RSVP to <u>iball@negrc.org</u> or 706-369-5650.
- 5. NEWTON COUNTY TOMORROW Newton County Tomorrow (NCT) held its first meeting since re-organization and expanded the Board of Directors to include the mayors of the five cities in Newton County. The Board now consists of nine elected or appointed officials and eleven citizens as at-large members.
- 6. OPEN MEETINGS REMINDER Attorney General Sam Olens has issued open meetings guidelines for public officials. Briefly, council members may not discuss the public's business in private meetings (with some exceptions), including those conducted by electronic means. Any citizen has standing to complain directly to the Attorney General's office. Civil penalties start at \$1,000 for the first offense. Criminal penalties may also apply. The city attorney will speak to this briefly tonight and if council wishes he will speak in greater detail at a future work session. Attachment G

Mayor Roseberry asked City Attorney David Strickland to give a brief summary of these new guidelines. Attorney Strickland said it's all about interpretation whether the discussion is in a meeting or electronically. He advised council they should take caution in predetermining a vote prior to a meeting. It would be best to reserve any comments in relation to a vote for the official meeting. Members can meet to discuss as long as there is no quorum.

<u>Charge for Sewer Availability</u> - City Manager Bob Schwartz presented a first reading of an ordinance by The City Council of the City of Oxford to Amend Chapter 36 Utilities, Article IV sewer service, by adding section 36-93 paragraph (h) minimum sewer charge if unconnected; to repeal all conflicting ordinances; to provide for severability, an effective date; and for other purposes. Attachment H

City Entrance Signs — Councilmember Terry Smith presented on behalf of the ad-hoc sign committee members Ms. Sarah Davis, Ms. Judy Greer, and himself. The goal was to create a recommendation to the Council for city limit signs. The guiding principle was to create signage that is simple and consistent, while at the same time reflective of Oxford's historic nature. Considerations were given to simplicity, aesthetically pleasing, focus on city, cost (initial cost as well as the cost of maintenance and/or replacement), warranty, ease of installation, rights-of-way issues such as easement or acquisition of property, DOT requirements, including safety and placement and consistency. Mr. Smith stated we have (9) nine locations in the city which need signage. Five (5) of these signs would be for Emory Street North and South, Old Oxford Road, East Soule Street and Moore Street these signs would be 24" x 36" hanging from the arm on a 4" x 4" black metal post. The other four (4) signs would be for East Richardson, West Richardson, Haygood and Stone Streets. These signs would be an 18" x 24" sign mounted on a 4" x 4" black metal post. The material is metal with a poly foam coating as presented to you tonight. For the wordage we focused on Oxford. We wanted people to know they are in Oxford and it was founded in 1839. The maximum cost of all (9) nine signs will be less than \$6,000. After discussion: Attachment I

A motion was made by Smith, seconded by Windham to approve the (9) signs as described from our current vendor Printability with a maximum cost of \$6,000. The vote was 7 in favor with 0 opposed. The motion was approved. After further discussion a motion was made by Eady, seconded by Smith to amend the original motion to hold off and change the wording on the signs to read Chartered 1839 rather than Established 1839 and to allow the committee time to come back with color samples before making a final decision. The vote was 7 in favor with 0 opposed. The motion was approved.

Management of Undeveloped Land Owned by the City – City Attorney David Strickland presented a draft license agreement for the use of city property for Jeffrey and Janice Wearing as it relates to the use of a portion of the unopened rights-of-way of Coke Street and George Street. After discussion:

A motion was made by Holt, seconded by Windham to table this item for further discussion at the March 16, 2015 work session. The vote was 7 in favor with 0 opposed. The motion was approved. Attachment J

The meeting will conduct an Economic Development workshop at City Hall on February 5<sup>th</sup>. The meeting will be about ECG services, cost allocation methodologies in preparation for ECG's FY16 budget. If you want to attend, ECG request you RSVP Rita Hillhouse at <a href="mailto:rhillhouse@ecoga.org">rhillhouse@ecoga.org</a> or call her at 770-563-1256.
- 3. The proposed meeting for the Board of Commissioners at Charles Elliott scheduled for February 13 has been cancelled.
- 4. Newton County Tomorrow is going through changes and reorganization. Mayor Roseberry was asked to join the board as chairman. After consulting with the city attorney to examine any possible legal conflicts with him accepting the position. Mayor Roseberry met with Newton County Tomorrow's Executive Director and after some discussion agreed to accept the appointment.

#### **Whatcoat Street**

City Engineer Robert Jordan gave an update regarding options of design for Whatcoat Street stating that the main focus and goal is to eliminate a large portion of asphalt while improving the connectivity to the post office and to Pierce Street. Jordan also presented a cost estimate as requested in prior meeting to survey the city right-of-ways. It was requested that Jordan do a layout of the south end of Pierce Street to show the connectivity to the sidewalk in front of Allen Memorial church.

#### Management of Undeveloped land owned by the city, including rights-of way

City Attorney David Strickland reported on the use and management of land owned by the city in respect to future planning, maintenance, liabilities and permitting private organizations or persons to use property whether it be temporary or long term. Strickland said the city can dispose of property as they see fit or they can allow continued use of property by way of a license and easement. Each would go with the property should they choose to sell, lease or purchase it. He suggested property should be leased at

market value or the city could choose to set a gratuity. Mayor Roseberry said continued discussion of these matters will be on the February work session agenda.

#### **Planning Commission Members**

City Manager Bob Schwartz stated the Planning Commission members serve three year terms on a rotating basis. This year the terms of Ron Manson and Vivian Harris expired in December 2014. Both member may be reappointed and both have said they are willing to serve another term. These two members will be on the February business agenda for reappointment by council.

#### **Grounds Maintenance**

City Manager Bob Schwartz informed council that the contract with Premier Tree and Shrub Care was for one year and may be renewed for one additional year. It was recommended the contract be renewed for 2015. This will be on the February meeting for a vote.

#### **Sewer Connection Status**

City Manager Bob Schwartz gave an update on where we are with the sewer connections. He stated we have three who have paid and connected, there approximately 18 whose notices will expire on February 5<sup>th</sup> and Chief Harvey will be writing citations where necessary.

#### **City Entrance Signs**

City Manager Bob Schwartz presented the final draft of the primary signs and the secondary signs for review by Council. After discussion it was decided there needed to be a slight modification made to the wording and some council members requested a sample of the composite material before a final vote.

#### **Honorary Councilmember Program**

City Manager Bob Schwartz asked should we continue this program on a monthly basis in 2015 or should we scale back to a quarterly program. After discussion the consensus was to continue on a monthly basis starting over with Councilmember Jim Windham who will appoint an honorary member for March.

Mayor Jerry Roseberry introduced Carol and Neil Penn as Honorary Councilmembers for April appointed by Councilmember Terry Smith. Everyone celebrated and joined in singing happy birthday to Mr. Penn as Mrs. Penn presented him with a birthday cake.

#### **Mayor Announcements and Reminders**

Mayor Jerry Roseberry – The city has been invited to be a sponsor of the Georgia Trail Summit in Athens June 4-6, 2015. A contribution of \$250 qualifies for two registrations (\$180 value), recognition in literature and a table in the networking area. The meeting is being sponsored by the National Park Services, Georgia Parks Department, NEGRC (North East Georgia Regional Commission) and others. John Devine of NEGRC is chairing the Host Committee. Everyone was in favor of the registration and promoting the city.

Mayor Jerry Roseberry – Made recognition of the passing of long time Oxford resident and Journalist Claude Sitton who set the pace for reporters covering the civil rights movement in the South in the 1950s and '60s and later won a Pulitzer Prize for distinguished commentary. Sitton was 89 years old.

#### **City Entrance Signs**

The ad hoc committee of Councilmembers Smith and Davis and Judy Greer reported on several alternatives for colors of the entrance signs and demonstrated four color options and language for the signs. This item will be on the April 6, 2015 agenda for a vote.

#### July 4th Parade

Councilmember Sarah Davis gave an update as Chairman of the Parade Committee. Items for discussion were as follows:

- 1. Committee members Sarah Davis as Chairman, Lauran Willis and Lisa Dorward. We will be asking members of the Lions Club to join the committee.
- 2. Parade Route Chairman Davis stated we need final decision on the Parade Route by the April 6, 2015 Regular Session as we have to send request to interrupt traffic to DOT by April 7, 2015.
- 3. Nominations for Parade Marshall should be submitted at the April 6<sup>th</sup> 2015, regular meeting for a vote or may be submitted to Chairman Davis prior to the April 6<sup>th</sup> meeting.
- 4. We need to ask for volunteers for Uncle Sam.

#### **Whatcoat Street**

City Engineer Robert Jordan presented council with several proposals for a layout of Whatcoat Street. Council asked that he develop a layout and cost concentrated on the mini roundabout and bring it back to council at a later date.

#### **Utilities**

Lisa Dorward of 1008 Emory Street presented a report regarding utilities and city policies with comparison to Georgia Power's rate plan and policies. Lisa asked that Oxford establish a program of assistance to help our neighbors suffering from financial hardship. This program would include: An application process to establish financial hardship, reduced rates for families within determined income levels, establishing a special fund similar to Project Share. She also asked that the excessive late fees be abolished. Lisa also asked that we adopt Georgia Power programs which offer a flat-rate pay program, discounted rates for seniors and the disabled and installment payment plans as well as adopt a humanitarian policy of placing a moratorium on disconnections during winter and summer months. In conclusion Lisa asked council to assign a committee to research a program called Pace Financing (Property assessed clean energy) which is a means of financing energy efficiency upgrades or renewable energy installations for buildings. The Pace program financing pays for 100% of the costs for making a home or building energy efficient. Is a reply to some of Lisa's concerns and questions Mayor Roseberry provided statistics on the decreased number of disconnects now compared to four years ago while the number of delinquents remain the same. He explained how the city absorbed the 16% increase when MEAG raised their cost rather than passing it along to the citizens, the city refunded deposits to customers who met certain requirements, the city now accepts credit cards as a payment option. As reply to Lisa's concerns regarding additional charges on the utility bills, Councilmember Terry Smith explained the (PCA) Power Cost Adjustment and the (ECCR) Environmental Cost Compliance Recovery. Councilmember Lyn Pace concurred with Ms. Dorward in that the city should provide some type of assistance for those citizens who cannot afford to pay their utility bill and/or research the possibility of some type of hardship fund. Mayor Roseberry expressed how the city is always looking for ways to provide better services to its citizens and thanked Lisa for her presentation.

#### 1020 Emory Street

Mr. Michael Besaw spoke to council regarding the possibility of purchasing a small lot from the city to add some space to his property at 1020 Emory Street as he presented at the March 2<sup>nd</sup> meeting. Mr. Besaw presented a letter in support of his request and asked council for consideration for assistance with his options. After discussion of his options Mayor Roseberry said council has not made any decision at this time. This item will be moved to a later date.

#### Coke and George Street Rights-of-Way

City Manager Bob Schwartz provided a draft copy of the license agreement discussed at the March 16th Work Session with a copy of the survey prepared by City Engineer Robert Jordan. It was agreed this item would be moved to the April 20<sup>th</sup> Work Session.

#### **Sewer Availability Ordinance**

City Manager Bob Schwartz – We had the first reading of an ordinance to require a charge for sewer availability. The city attorney will have a report on its legality before it is considered for a second and final reading at the April meeting.

#### **101 Longstreet Circle**

City Manager Bob Schwartz – This burned out house was donated to the city. Utility Superintendent Jody Reid has talked with Mr. Gordon Reynolds of AXIS Remedial Sciences who is an accredited asbestos inspector. Mr. Reynolds pricing includes, all permitting, fees and regulated waste disposal and is contingent on all services proposed performed in a single mobilization. All performance will be conducted in accordance with local, state and federal regulations. The total cost should be \$880.00 if he obtains less than 10 samples the cost will be less and if it is determined that more than 10 samples, are needed they will seek verbal approval before exceeding the maximum of \$1,200.00. The City will be responsible for allowing AXIS Remedial Sciences into the structure. Jody said the demolition contractors have indicated they need clearance for asbestos before they can proceed with demolition.

#### **Zoning Amendment**

A

City Manager Bob Schwartz – Oxford College recently purchased four lots on the east side of Emory Street. They have asked to rezone three of these lots (602, 604, and 608 Emory) from R7.5 to IC (Institutional Campus). At this time they are not requesting any change in the zoning for the larger lot (approximately 12 acres) which, if it had a house on it, would be numbered 606. The Planning Commission reviewed this request on Tuesday, March 10. After considerable discussion, the Planning Commission recommended that the three lots be rezoned to IC-TA (Institutional Campus—Transitional Area) subject to the conditions and limitations that the only permitted use be residential uses consistent with the existing land use plan and office use (approved as a conditional use in the IC-TA zone) provided that the buildings remain on a single family residential scale and appearance. The intent being that the properties continue to appear as single family residential use. To conclude Bob stated a public hearing has been scheduled for 7 PM at the beginning of the council meeting on April 6<sup>th</sup>. If the zoning change is approved, then the Oxford College Future Development Plan will be amended to include these four lots as college property with the conditionally approved use as offices for the three houses.

#### **Hamill Street**

City Manager Bob Schwartz — Oxford College has requested that Hamill Street between Haygood and Emory be closed to vehicular traffic. The Planning Commission considered this request at its March 10<sup>th</sup> meeting and recommends approval subject to the college installing a brick walk way in place of the asphalt and installing breakaway bollards at both ends of the street. The Planning Commission also felt that a pedestrian crossing on Emory Street would enhance this request. The brick walk way would improve the esthetics for this part of the campus while maintaining access for emergency vehicles. A copy of the proposed layout was presented in the agenda packet. It was agreed to table discussion for this item until the April work session.

#### **Projects Status Report**

City Manager Bob Schwartz presented a Projects Status Report through March 16<sup>th</sup>. He asked council to review the report and contact him with any questions.

There being no further discussion the meeting was adjourned at 8:00 PM.

#### TRANSFER OF FUNDS




#### **GEORGIA TRAIL SUMMIT**

A marker recognizing General Sherman's march through Oxford has been installed across the street from Old Church.



The parcel is only 136' X 105', 14,820 square feet. (The width of my property 136', and only 105' back)







## STATE OF GEORGIA COUNTY OF NEWTON

AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF OXFORD TO AMEND CHAPTER 36 UTILITIES, ARTICLE IV SEWER SERVICE, BY ADDING SECTION 36-93 PARAGRAPH (H) MINIMUM SEWER CHARGE IF UNCONNECTED; TO REPEAL ALL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY, AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the City pursuant to O.C.G.A. Sec. 36-35-3 known as the "Home Rule for Municipalities", is authorized under paragraph (a) of the rule to adopt clearly reasonable ordinances, resolutions or regulations related to its property, affairs, and local government for which no provision has been made by general law and which are not inconsistent with the Constitution or any charter provision applicable thereto; and

WHEREAS, the Mayor and Council of the City deem it in the best interest of the government and the residents of the City, and further as a matter of public safety, to establish a minimum sewer fee for those owners whose properties lie within the City, and which are required to be connected to public sewer, but who have failed to timely complete the connection; and

WHEREAS, the Mayor and Council of the City of Oxford have determined that the proper means of addressing said concern is to amend Chapter 36: Utilities; Article IV: Sewer Service: Section 36-93: Use of Public Sewers Required; and

**NOW THEREFORE**, be it ordained by the Mayor and Council of the City of Oxford that Chapter 36: Article IV: Section 36-93 be amended by adding paragraph (h), as follows:

(Additions are in underlined bold italics)

Section 1.

Section 36-93 Use of public sewers required.

(h) Minimum sewer charge if unconnected. Any owner of a property situated within 100 feet of rights-of-way containing public sewer, who has been timely notified of the requirement to connect to the public sewer line as required by paragraph (e), and who has not done so, shall be

charged the minimum sewer charge each month until the required connection is properly made. This charge shall begin at the conclusion of any associated judicial proceedings, and shall be included within the City's utility bill and shall be in addition to any judicial penalties incurred for failing to comply with the requirements of paragraph (e).

## Section 2. Repeal of All Ordinances in Conflict

All ordinances and resolutions or portions thereof in conflict with this ordinance are repealed to the extent of their conflict.

## Section 3. Severability

If any section, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance, and such remainder shall remain in full force and effect.

#### **Section 4. Effective Date**

Pursuant to Sec. 2-21 (9) (D), this Ordinance shall be in full force and effect five (5) days after its final passage.

Second reading and adoption, this 6th day of April 2015.



GABE PROPERTIES: At the February meeting, the Planning Commission authorized the chair to issue a development permit for the garage at 201 Williams Street when presented with a boundary survey which shows the entire property and locates the current and proposed structure accurately on the survey. Mr. Ready reported that the proper survey had been submitted; that it met the zoning code requirements; and that he and Mr. Schwartz had approved the development permit. As an aside, he noted that the original surveyor contacted by GABE properties had, in turn, contacted Robert Jordan for some background information. After some discussion the original surveyor had asked Robert Jordan to do the survey. It was just too complicated to handle.

Oxford College Jolley Residential Sign — Oxford College has submitted a request for the approval of a double sided sign on Pierce Street to identify the Jolley Residential Center. Ms. Mayfield explained that the signs were to better identify the Jolley Residential Center for emergency vehicles. The sign on Few Circle did not require the approval of the Planning Commission because it was not on city right-of-way. The sign on Pierce Street would be on the right-of-way but is located 15 feet from the curb.

Upon motion of Mr. Eady, seconded by Ms. Gaither, the request for the sign was approved as submitted. All members voted in favor.

Oxford College Future Development Plan Amendment and Rezoning Request — Oxford College has purchased four lots on the east side of Emory Street (602, 604, 606, and 608 Emory). The college would like to use the houses at 602, 604, and 608 as offices. This request is both an amendment to the Future Development Plan and a rezoning request for 602, 604, and 608 Emory from R7.5 to IC. The request does not include the property at 606 Emory which is the approximately twelve acre tract.

The Planning Commission discussed the <u>Criteria for Amendments to the Official Zoning Map</u> §40-638 (g) (1 through 8) and this request with Ms. Mayfield. The members noted the

advantage of keeping the same look as residential houses. After considerable discussion the following motion was made.

Upon motion of Mr. Eady, seconded by Ms. England, the Planning Commission recommended to City Council that the three lots be rezoned from R7.5 to IC-TA (Institutional Campus — Transitional Area) subject to the conditions and limitations that the only permitted uses be residential uses allowed in the R7.5 zone and which are consistent with the existing land use plan and college office use (approved as a conditional use in the IC-TA zone); provided that any and all buildings on the lots remain on a single family residential scale and retain a single family residential appearance that is consistent with the surrounding residential dwellings. The intent being that the properties continue to appear as single family residential use. All members voted in favor.

Oxford College Future Development Plan Amendment and Request to Close Street — Oxford College has requested that Hamill Street be closed to vehicular traffic between Haygood and Emory and that the college be permitted to install a brick walk way on the right-of-way. After a recommendation from the Planning Commission, City Council will vote on the street closing.


The Planning Commission conducted a vigorous discussion of the reasons for or against closing the street. Mr. Schwartz reported that he and Ms. Mayfield were working with GDOT on the possibility of a marked pedestrian crossing with caution lights on Emory Street (SR81). If Hamill Street was closed to traffic that would become the ideal location for a pedestrian crossing. After further discussion the motion was:

Upon motion of Mr. Manson, seconded by Ms. Gaither, the Planning Commission recommended that City Council approve the closure of Hamill Street between Haygood and Emory to vehicular traffic based on the agreement of Oxford College: to install and maintain a brick walk way and breakaway traffic bollards at both ends of the street and to pay the cost of maintaining Hamill Street for pedestrian traffic and emergency vehicles for the duration of such closure to vehicular traffic.

ADJOURNMENT: Mr. Ready adjourned the meeting at 8:45 PM.
