Finance/Oversight/Personnel

Mayor Roseberry: This is a process required for governmental accounting. The money being transferred is for all of the capital money being spent this year for electrical improvements and other capital improvements. It is put in the budget to account for the cash flow. This is money that has been set aside for capital improvements which has to be put in the budget to account for the cash.

Oliver delivered the first reading of an ordinance amending the code of the City of Oxford, Georgia, Chapter 3, "Administration", Article VI, "Officers and Employees, to amend section 3-605 "Officers and Employees", and section 3-309; "Zoning Administrator" to replace any references of City Clerk with city Manager.

This replaces this present ordinance which reads the city clerk is administrator of the city. In both instances now that we have a city manager this ordinance will replace city clerk with city manager as administrator and zoning administrator.
